ISPO Winter is the largest European sporting goods trade fair and is seen as the springboard into Europe and beyond. Last year the show had over 64,000 trade visitors, 65% of which were from outside Germany, reflecting the international status of the show.

After the success of last years pavilion, the FSPA is again organizing an exhibiting group, we have reserved an area in the C Halls which is the Team Sports area. As part of the group exhibitors are provided with:

- high quality stand build & distinctive shell scheme stand in a key position within the show
- support services prior to & throughout the period of the show
- furniture package including electrics, carpeting and display panels
- marketing of the group in UK and European trade press
- trade fair participation fee (€115 per company)
- services of a group freight forwarder (exhibitors responsible for own freight costs)

The cost of exhibiting with the FSPA is **£225 per square metre** plus a management charge of £250 for FSPA members and £375 for non-members. Eligible companies may also apply for an export grant available through UK Trade & Investment. Priority will be given to those companies who are either ***new to export*** or ***new to market***.

Exhibitor Terms & Conditions

The Federation of Sports & Play Associations which is a UKTI accredited trade organisation is managing this exhibition and the Federation's terms and conditions apply to all exhibitors taking part in ISPO Winter 2010.

Failure to comply with any of these conditions may result in your company being refused participation in any future FSPA export event.

- No space will be reserved without payment of the stipulated deposit.
- An exhibitor who wishes to withdraw from the exhibition must accept any financial penalties that are levied by the show organisers (Messe München GmbH). The Federation will only reimburse deposits to companies who withdraw from the show prior to the cut-off date (**31st August 2009**) and whose withdrawal is justified in writing. Companies withdrawing late (within three calendar months of the exhibition) will be liable for the full costs of the stand.
- Exhibitors must meet all of the costs of their participation in the exhibition. Full payment for the stand must be received by the Federation at least 30 days prior to the event.
- Exhibitors must provide the Federation with information about the products or services they wish to promote, and complete a UK group catalogue entry form, in advance of the exhibition.
- Exhibitors must have a company representative on their exhibition stand for the duration of the show.
- Exhibitors wishing to apply for an export grant must complete the relevant UKTI application form and return it to the Federation prior to the stipulated cut-off date.
- Exhibitors in receipt of UKTI export grants must adhere to all UKTI Terms and Conditions as provided with the grant application form.
- Exhibitors claiming export grant must be United Kingdom companies seeking to promote UK goods or services.
- Exhibitors claiming an export grant must complete the relevant UKTI questionnaire after the show.
